- These funds will assist individuals experiencing homelessness, at-risk of homelessness, Domestic violence, and human trafficking
- M & L Consulting facilitating city engagement with review from HUD this fall
- This is open to public housing, COC, service and shelter providers and the housing authority
- Population must be qualifying
- Allocation Plan – 2.9 how will the city allocate the funding: (1) Productive/Rehab, (2) tenant rental, (3) non- congregate, (4) supported services – what’s the capacity?
- The team still needs to meet with community groups
- Survey to be developed and stakeholder sessions to be held
